 - Reality is that we'd get put on track with cars unless we had big numbers


























- Bremmer Ford


4. TREASURER'S REPORT

5. GENERAL BUSINESS

- On track conduct between different classes
 - o A conduct statement was read out by Doug and agreed to by drivers at round 3.
 - Statement is as follows
 - "A kart passing on the inside must have the most forward part of their kart inline or past the front wheels of the kart they are passing before the turn in point for the corner. If they are unable to do so the passing kart should yield the corner"
 - o Members agreed this was adequate and will be followed.
- Honorary member form change
 - Topic moved to next meeting
- Head Rests
 - Head rests are a good idea but it isn't something that is easily fitted to a sprint kart
 - o Some more research is needed before making any recommendation on this.
- Neck and rib protectors
 - o This is personal preference form driver to driver
- Round 3 feedback
 - Mixed opinions from members about lakeside
 - o All can agree the track is extremally bumpy and run off areas are dangerous
 - o Some members have pointed out they will not race at lakeside in its current state


